Freer Park Donation:

Wood stove ordinance/complaint:

Trustee Harns requested information of the Board as to their knowledge of the complaint. Harris explained what the Zoning Commission has offered, LaGrow explained the options that were given to the resident to validate and file a nuisance complaint.

Roads:

Motion by LaGrow, second by Harns, if allowed by the new administration of the Road Commission, to carry over the 2022-2023 Budgeted Road funds to add to the 2023-2024 Budget Road Fund to allow for a greater portion of Potter Rd. to be repaired at once. If denied, discussion would be held during the August Meeting. All in favor, motion carries.

Harris asked attorney Matthew Kuschel to explain what impact this ordinance would have on the likelihood of prospective businesses suing the township. Kuschel explained that the entire year-long process was designed to take into account the property rights of all citizens in the township, including those who might be interested in siting wind turbines in Ingham Township. He also explained that this ordinance protects the health, safety, and security of Ingham Township residents by enacting appropriate safeguards while also allowing businesses to implement wind farms in Ingham Township as long as they follow the rules set forth in the ordinance.

BUDGET AMENDMENTS:

Speck made motion, second by Braman, to re-adopt Final 2021-2022 Budget, as the technology issues were resolved, allowing for all Funds to Balance accurately and stated a one-year audit will be performed verses the required two year, to allow for corrections and education while still in the learning phase.
